will be \$1,200. Beginning in 2010, the amount
will be increased each year by therfare of
inflation. The rate of inflation is the increase in
the Consumer Price Index for urban consumers
prepared by the U.S. Bureau of Labor Standards.
The proposed revenue would be authorized for
eight years, unless otherwise revoked or reduced
